That you acknowledge that the owners and operators of **Kootenay Lazer Tag** have employed diligent efforts and care in making the **Kootenay Lazer Tag** Property as safe as possible; and that despite the foregoing efforts, you are AWARE OF THE RISKS, DANGERS, AND HAZARDS ASSOCIATED WITH USING THE **Kootenay Lazer Tag** property, which risks include but are not limited to, possible trips, falls, collisions with other people or objects, AND FREELY ACKNOWLEDGE SUCH RISKS AND THE POSSIBILITY THAT YOU MAY SUFFER PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS and agree to use **Kootenay Lazer Tag** property with full understanding of same
